The proposed corridor for study extends along South Western Avenue from Evergreen Park at 83rd Street to Vermont Street in Blue Island. The project crosses multiple jurisdictions including Evergreen Park, City of Chicago, and Blue Island. Illinois Department of Transportation may also have jurisdiction on certain sections of South Western Avenue through the project area.

Pace and CTA both operate within the study area:

- CTA Route 95 (95th to 91st)
- Pace bus 349, 385 (127th south)
- CTA cross street routes 87, 103, 112, 119
- Pace bus cross street routes 381 (95th Street)

Beginning at 83rd Street, the project would allow for improved connection to the Major Taylor Trail on the north end and the Cal-Sag Trail on the south end of the project limits at Vermont Street. Opportunities also exist to provide improved accessibility to the on-street bike route network along many of the east-west streets including 87th Street, 99th Street, 103rd Street, 111th Street, 115th Street, and 119th Street, connecting to additional bike routes along Longwood Drive and South Vincennes Avenue.

If yes, please list the name of the plan(s) There have not been any holistic plans developed for this section of Western Avenue in the last five years. Both Blue Island and City of Chicago have investigated the South Western Avenue Corridor in different contexts in 2011 and 2013, respectively. Some elements of these plans were implemented, but a holistic, cohesive effort has not been completed for the full proposed project area.

What is the goal of this plan? What are you looking to accomplish?

The goal of this study is to identify opportunities to improve safety, mobility, and economic vitality along the corridor, with special attention to non-motorized access and mobility and transit improvements. The South Western Avenue corridor is extensively developed with retail, but the roadway is designed to maximize vehicular throughput. There is a significant crash history throughout the corridor, highlighting the conflicts between land use and current roadway design. An equitable and multimodal implementation plan is the end goal for the corridor plan that matches the overarching themes of CMAP's ON TO 2050 Plan: Inclusive Growth: Growing our economy through opportunity for all; Resilience: Preparing for rapid changes, both known and unknown. Prioritized Investment: Carefully target resources to maximize benefit. The holistic approach taken for this corridor study will include the following: upgrade ADA requirements throughout the corridor; look to improve pedestrian and non-motorized user safety and mobility; consolidate vehicular access and improve access patterns to big box retail; review traffic control options including signal timing timing and phasing; improve access for all modes to jobs, education, and healthcare; improve the overall reliability of transit through the corridor; subsurface utility replacement and/or upgrades as necessary to improve and expand telecommunications, improve drainage/water/wastewater infrastructure, replace any lead service lines remaining in the corridor; look to bury overhead utility lines to improve resiliency.

The largest Evergreen Park racial/ethnic groups are White (non-Hispanic) (55.4%), Black (Non-Hispanic) (24.5%), Hispanic or Latino (of Any Race) (14.7%), Asian (non-Hispanic) (2.1%), and Other/Multiple Races (Non-Hispanic) (3.3%). Total non-English spoken at home was 14.5% (10.9% Spanish) with 3.5% responding speaking English Less than "Very Well".

The Beverly neighborhood area's racial composition in 2021 was 55.3% white, 32.4% Black, 1.3% Asian and 3.7% other racial categories. Hispanics or Latinos of any race made up 7.2% of the population.

The Morgan Park neighborhood area's racial composition in 2021 was 33.1% white, 28.8% Black, 6.8% Asian and 2.7% other racial categories. Hispanics or Latinos of any race made up 28.7% of the population.

Blue Island's racial composition in 2023 was Hispanic or Latino (of Any Race) (45.9%), Black (Non-Hispanic) (31.4%), White (non-Hispanic) (21.1%), Asian (non-Hispanic) (0.05%), and Other/Multiple Races (Non-Hispanic) (1.1%).
