Ordinance approving the Section 5310 Enhanced Mobility for Seniors and Individuals with Disabilities Program of Projects

Ms. Heather Tabbert presented an overview of the Section 5310 program, highlighting that the program provides federal funding to support operating and capital projects that support seniors and people with disabilities. The RTA has administered this program, and previous similar programs, since 2006. Ms. Tabbert reviewed the 12 projects recommended for inclusion in the FFY 2016 & FFY 2017 Program of Projects. These included Association for Individual Development–Ride in Kane, City of Naperville –Ride DuPage to Work, DuPage County–Transportation to Work, Kendall County–Kendall Area Transit, Lake County–Ride Lake County Central Dial-a-Ride, Lake County–Ride Lake County West, Little City Foundation–Transportation Program, McHenry County–McRide, Will County–Will Ride, and Ray Graham Association for People with Disabilities–Ensuring Access to the Community, CTA–Tactile Signage at CTA Bus Stops, and Pace–Regional Call Center. The total program budget is \$14,936,856 including \$8,756,052 federal funding and \$6,180,804 in local matching funds. No RTA funds are needed to support the program.
