6a. Update on the activities of the RTA Transit Access Citizens' Advisory Board

Description: The purpose of the RTA Transit Access Citizens Advisory Board (RTACAB) is to obtain community input on the full spectrum of programs and services offered by the RTA. The RTACAB's bylaws require that its chairperson make quarterly reports to the RTA Board of Directors regarding the progress of the Committee's work. RTACAB Chairwoman, Jackie Forbes, will provide an update at the May 2023 Board meeting. This update will be for informational purposes only and will require no vote.

7a. Resolutions certifying financial results - First Quarter 2023

Description: The proposed resolutions certify that the operating financial results of CTA, Metra, Pace Suburban Service, ADA Paratransit, and the Region as a whole, through the first quarter of 2023, are in substantial accordance with the budget adopted on December 15, 2022.

7b. Amendment of the 2023-2027 Capital Program

Description: The proposed amendments incorporates changes in projects, program revenue, and expenses for CTA and Metra.

7c. Ordinance Approving the 2024 Budget Call for the Annual Operating Budget, Two-Year Financial Plan, and Five-Year Capital Program

Description: The proposed ordinance approves and releases the 2024 Budget and Capital Program Call (the "Budget Call"). The Budget Call defines the schedule and information requirements that the Service Boards must follow for the development of the 2024 Budget, which includes the 2024 Operating Budget, 2025-2026 Two-Year Financial Plan, and 2024-2028 Five-Year Capital Program

7d. Ordinance Authorizing the Purchase of Excess Liability Insurance Policies by the RTA's Loss Financing Plan / Joint Self-Insurance Fund

Description: The proposed ordinance authorizes the purchase of excess liability insurance policies by the RTA's Loss Financing Plan/Joint Self-Insurance Fund. RTA's current policies expire on June 15, and renewal policies are required to ensure continuous coverage in the event of a claim.
