of financial assistance from the Federal Transit Administration (FTA) are required to adopt Title VI programs to ensure non-discriminatory practices and meaningful access to benefits, services, information, and important activities for all persons regardless of race, color or national origin. The program must also contain the Agency's plan for meaningful participation by individuals with limited English proficiency.
